

ΘΕΜΑ: Συνοριακοί κτηνιατρικοί έλεγχοι από τις αρμόδιες τουρκικές υπηρεσίες για την είσοδο προϊόντων στην Τουρκία

Αποστέλλεται, συνημμένα, η υπ' αριθμ. 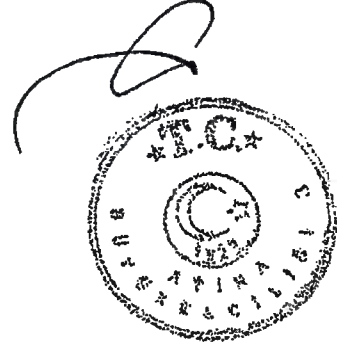

In accordance with the provisions of the "Regulation of Veterinary Controls on the Entry of Products into the Country" published in the Official Gazette Issue No: 28145 on 17.12.2011, the entry of products subject to veterinary controls into Türkiye are subject to official controls made by the Veterinary Border Inspection Posts (VBIP) under the supervision of the Ministry of Agriculture and Forestry of the Republic of Türkiye.

The extent of the products subject to veterinary controls are determined according to the provisions of the "Regulation on Animals and Products Subject to Veterinary Controls upon Entry into the Country", published in the Official Gazette Issue No: 28149 on 21.12.2011.

In order to determine whether a product would be a subject to veterinary controls or not, documents such as "Content Document" and "Ingredient Percentage List" are required.

Some Turkish VBIPs has reported some cases reported to the Turkish Ministry, in which the authenticity of "Content Document" and "Ingredient Percentage List"s are deemed questionable on some products, especially composite products for human consumption and feedstuff for animal consumption.

With regard to the above, manufacturer companies must send a copy of the relevant documents which are used for the determination of a product would be subject to veterinary controls, (such as "Content Document" and "Ingredient Percentage List" as well as product batch/lot numbers) from the Manufacturer's official e-mail address to the official e-mail addresses of the Turkish Veterinary Border Inspection Posts where the shipment will enter.
